**Pandora Vreeland** requested that the "excess" money in the school building program be used to pay down the debt or be refunded to the tax payers. She also requested that the Mayor consider appointing **Pat Hunter** as a County resident member of the Budget Committee.

**Pat Hunter** suggested keeping 20 cents of the excess funds in the school building program and use the remaining excess to pay down the debt. She offered suggestions of places to cut the budget – Commissioners salaries, meals, travel and furniture, etc.

**Sheriff Tim Guider** appealed for funding for his department saying that the people of the County need to feel safe and that currently the scales were tipping toward the perpetrators. He said that patrols need to be beefed up and that the drug problem is getting worse. He said that it's his job to provide services to the County and to keep the Commission informed of his department's needs.

**Wayne Schnell** said that Legislators were doing a good job in lowering taxes and keeping services in place. He thinks the County needs a 10% reduction in spending. He applauded the recommendations of the Budget Committee. He wants to see a hiring freeze on County employees and wants the Rural Debt money to stay there. **David Clinton, Principal of Highland Park Elementary,** urged the Commission to keep the funding in the School Fund and said the School Board and the Commission should be working together.

**Allison Millsaps, Loudon County School System**, urged the Commission to leave the pennies in the School Fund.

**Teresa Stang**, speaking for her husband also, asked that there be no increase in County employees salaries stating that others in the County are not so fortunate as they are and don't have the benefits that they have. She stated that Medicare costs are up 66%.

**Cheri Parrish, Principal, Loudon County High School,** urged the Commission not to move the money from the school fund.

**Marcia Warren, Philadelphia School,** said that the kids in Philadelphia School were very excited about their new cafeteria and she urged the Commission to protect the school funding for the schools - don't move it.

He distributed a graph that he had from CTAS showing that Loudon County Commissioner's salaries were out of line with counties of similar size and therefore they should be reduced. He said that how much of a reduction can be discussed and agreed upon in a full Commission Workshop. Commissioner Franke asked if these other counties paid mileage, etc. and Commissioner Miller responded that this information was not available. Commissioner Harrelson said that he agrees with this amendment and the recommendation to discuss this further at a future Workshop meeting. There was further discussion regarding the vote on this item at the Budget Committee meeting which included a legal opinion that Mayor **Herron** had requested from the County Attorney. **Commissioner Shaver** also clarified that opinion. Commissioner Meers concluded the discussion by saying that he agrees that the Commission needs to make cuts across the board and he hopes they will be fair cuts and that County residents will be fair with the Commission.

Commissioner Yarbrough stated that this decision was not based on the quality of services but on the economic situation and she encouraged this group to work with citizen's groups. Commissioner Harrelson said that this group has a larger budget but they have a very large area to serve and that they do a good job for the County and he extended his gratitude and appreciation for the job they have done.

#### PROPOSAL

# OF THE DEPARTMENT OF TRANSPORTATION OF THE STATE OF TENNESSEE TO THE COUNTY OF LOUDON, TENNESSEE

The DEPARTMENT OF TRANSPORTATION of the State of Tennessee,
hereinafter "DEPARTMENT", proposes to construct a project designated as No. NHTSAHE-2(216); 97053-2221-04 that is described as S. R. 2 (E. Lee Hwy) Intersection with S.R.
324 (Sugarlimb Road) Signalization and Intersection Improvements in the COUNTY of
LOUDON, hereinafter COUNTY, provided the COUNTY agrees to cooperate with the
DEPARTMENT as set forth in this proposal, so that the general highway program may be
carried out in accordance with the intent of the General Assembly of the State.

Accordingly, if the COUNTY will agree:

- 1. That in the event any civil actions in inverse condemnation or for damages are instituted by reason of the DEPARTMENT, or its contractor, going upon the highway right of way and easements, and constructing said project in accordance with the plans and as necessary to make the completed project functional, it will notify in writing the Attorney General of the State, whose address is 404 James Robertson Parkway, Nashville, Tennessee 37243-0487, of the institution of each civil action, the complaint and all subsequent pleadings, within ten (10) days after the service of each of the same, under penalty of defending such actions and paying any judgments which result therefrom at its own expense; and
- 2. To close or otherwise modify any of its roads or other public ways if indicated on the project plans, as provided by law; and

- 3. To transfer or cause to be transferred to the DEPARTMENT without cost to it, all land owned by the COUNTY or by any of its instrumentalities as required for right of way or easement purposes, provided such land is being used or dedicated for road or other public way purposes; and
- 4. Where privately, publicly or cooperatively owned utility lines, facilities and systems for producing, transmitting or distributing communications, power, electricity, light, heat, gas, oil, crude products, water, steam, waste, storm water not connected with highway drainage, and other similar commodities, including publicly owned facilities such as fire and police signal systems and street lighting systems are located within the right of way of any road or other public way owned by the COUNTY, or any of its instrumentalities, the COUNTY agrees that it will take action necessary to require the removal or adjustment of any of the above described facilities as would conflict with the construction of the project. But the foregoing may not be a duty of the COUNTY since it shall become operative only after the DEPARTMENT has been unsuccessful in its efforts to provide for said removals or adjustments for the benefit of the COUNTY.

The foregoing does not apply to those utility facilities which are owned by the COUNTY or one of its instrumentalities, it being understood that the COUNTY has the duty to relocate or adjust such facilities, if required, provided the COUNTY is notified to do so by the DEPARTMENT with detailed advice as to this duty of the COUNTY; and

- 5. To maintain any frontage road to be constructed as part of the project; and
- 6. That after the project is completed and open to traffic, to accept for jurisdiction and maintenance such parts of any existing DEPARTMENT highway to be replaced by the project, as shown on the attached map; and

- 7. That the COUNTY will make no changes or alter any segment of a road on its road system that lies within the limits of the right of way acquired for any interchange to be constructed as part of the project and will not permit the installation or relocation of any utility facilities within the right of way of any such a segment of one of its roads without first obtaining the approval of the DEPARTMENT; and
- 8. That no provision hereof shall be construed as changing the maintenance responsibility of the COUNTY for such part of the project as may presently be on its highway, street, road or bridge system; and
- 9. That it is understood and agreed between the DEPARTMENT and the COUNTY that all traffic control signs for the control of traffic on a street under the jurisdiction of the COUNTY and located within the DEPARTMENT'S right of way shall be maintained and replaced by the COUNTY; and
- 10. That when traffic control devices for the direction or warning of traffic, lighting of roadways or signing, or any of them, which are operated or function by the use of electric current are constructed or installed as part of the project, they will be furnished with electricity and maintained by the COUNTY.
- 11. If, as a result of acquisition and use of right of way for the project, any structures that become in violation of a COUNTY setback/building line requirement, the COUNTY agrees to waive enforcement of the COUNTY setback/building line requirement and take other proper governmental action therefor.

The acceptance of this proposal shall be evidenced by the passage of a resolution, or by other proper governmental action, which shall incorporate this proposal verbatim, or by reference thereto. Thereafter, the DEPARTMENT will acquire the right of way and easements, construct the project and defend any inverse condemnation or damage civil actions of which the Attorney General has received the notice and pleadings provided for herein.

The project plans hereinbefore identified by number and description are incorporated herein by reference and shall be considered a part of this proposal, including any revisions or amendments thereto, provided a copy of each is furnished the COUNTY.

# Origin Of Appalachian Regional Commission (ARC)

- 1960, the Council of Appalachian Governors, from the Appalachian states of Alabama, Georgia, Kentucky, Maryland, North Carolina, Pennsylvania, Tennessee, Virginia, and West Virginia, united to seek federal government assistance for the mountainous portions of their states, which lagged behind the rest of the United States in income, education, health care, and transportation.
- 1960 John F. Kennedy met with the governors to hear their concerns and observed living conditions in West Virginia that convinced him of the need for federal assistance to address the region's problems.
- Established by the United States Congress in 1965, when Appalachia was considered "a region apart" from the rest of the nation
- ARC has worked to bring Appalachia's 22 million people into America's economic mainstream.










# The Money Is There


- Currently Available For Corridor K: \$255.5 million

- Environmental impact Study for Sections B&C in 2008. (Stecoah to Robbinsville)
- Oct. 2009: Public Hearings were held about Corridor K. Hearing was not well attended by local residents. Some attendees were part time residents who have summer homes.
- Nov. 2009 Based off the feedback at the Oct. 2009 Public Hearing, NCDOT received correspondence from NC Division of Water Quality and USACE requiring that they examine improving existing routes. Due to lack of advertising, meeting was not well attended by loca lresidenrs


- Spring of 2010- Based off USACE and NCDWC and Comments from the public hearing, NCDOT began examining options to improve existing Hwy 143 and NC 28.
- Dec. 2011- Results of the study improve existing Hwy. 143 and NC 28 we released at the merger team meeting.
- Conclusion: Improving the existing roads was not a practical alternative. Improving existing roads had considerably more impacts to the Nantahala National Forest and impacted the Appalachian Trail when the proposed routes for Corridor K do not. Result: Neither the USDA Forest Service nor the NPS support improving existing roads.
- May 17, 2011- Corridor K Public hearing at Robbinsville High School. Due to proper advertisement and word of mouth, this meeting was better represented by local tax paying citizens who reside in the affected Counties.

The road has been studied since 1984, 27 years, while other roads are being conceived and completed all over the state.


## Population Change in Appalachia, 2000–2010


(Population Change as a Percentage of the 2000 Population

(Effective October 1, 2011 through September 30, 2012)






## Ecological Impact Of Corridor K




### North Carolina's Portion Of Corridor K Three Sections



# Regional Tourism Impact Scenic Byways & Touring Roads Of The Southern Appalachians

- Of Note: U.S. 64, although designated a "scenic byway", visitor traffic must compete with logging trucks and other oversized vehicles on this two lane roadway.
- By moving commercial traffic to the new Corridor K, U.S. 64 would see a significant increase in tourism comparable to the Blue Ridge Parkway, one of the most visited "attractions" in North Carolina.
- Increased Tourism Dollars will provide seed monies for additional marketing efforts by regional counties, further expanding their tourism base.
- Economic Impact Studies conclude that completion of the Corridor K show projected market increases of 25-50% for Graham County and 50-100% increase for Swain County with accessibility brought up to national standards.




## Scenic Highway Road Closures

Road closures due to rockslides in 2009 put increased pressure on other regional scenic byways.

- U.S. Hwy. 129 Great Smoky Mountains Closed due to rockslide
- Hwy. 64 Ocoee River Gorge Closed due to rockslide
- Interstate I-40 Great Smoky Mountains Closed due to rockslide

These extended closures put increased commercial and tourist traffic on even smaller highways through the national forest lands during the closures for repair.




