REGULAR COMMISSION MINUTES

(1) Opening of Meeting

BE IT REMBERED, that the Board of Commission of Loudon County convened in regular session in Loudon, Tennessee on the 4^{th} day of December 2023.

Commission Chairman Cullen called the meeting to order at 6:00 pm.

Commission Chairman Cullen opened the County Commission Meeting by leading the Pledge of Allegiance to the Flag of the United States of America, and then gave the invocation.

(2) Roll Call

Upon Roll Call, the following commissioners were present: Chase Randolph, Bill Geames, William Jenkins, Rosemary Quillen, Bill Satterfield, Gary Whitfield, Henry Cullen, Joe Morrison, Van Shaver, Adam Waller (10)

Also present, were the Mayor - Buddy Bradshaw, and Chief Deputy – Tammie Wampler.

Director of Accounts and Budgets - Erin Rice was absent from the meeting.
