Superintendent Dukes reported that it looked as if it would take another 6 weeks to complete the Highland Park addition, and possibly 3 months on the Steekee School.

Judge Sproul reported that the Tellico Project Road Committee had met and made recommendations to be sent back to TVA for further discussion, and that a more complete report would be offered to the Quarterly Court at a later date.

Squire Conner gave the Hospital Report, after which followed considerable discussion, and a motion by Squire Hartsook, seconded by Squire Blair, that the County Judge appoint a committee to include at least two members from the Hospital Board, two from the Quarterly Court, and the County Judge, the Committee to be responsible as a co-ordinating Committee with the Hospital Board and the Quarterly Court to co-ordinate efforts to make a recommendation about the use of the old part of the Charles H. Bacon Wing, and that \$500 be appropriated from the Unallocated Fund to be used as expenses for the Committee in its efforts, along with \$500 to be requested from the Hospital. After considerable discussion, the motion passed unanimously with all Squires voting aye.

Judge Sproul reported on the situation concerning the Regional Correctional Center and its relationship to the question of building an adequate and safe new Loudon County jail, indicating that the State itself was strongly considering Regional Correctional Centers, and that Loudon County was still being considered as the possible site for such a Center; and that if such a center were placed here that it would significantly change the requirements for the type and capacity of facilities that would be needed for the local jail. After considerable discussion, it was moved by Squire Foster, seconded by Squire Hartsook, that Sheriff Freeman Russell, Dennie Martin, ETOSPC, the County Judge, and Squires Bledsoe and Blair act as a Committee to come up with a recommendation concerning the County Jail as soon as circumstances would permit. The motion passed unanimously, with all Squires voting aye.

It was moved by Squire Conner, seconded by Squire Blair, and unanimously approved by all Squires, that the following amendments be made to the Budget:
