## OCTOBER 4, 1976

Be it remembered that the Quarterly County Court of Loudon County met on Monday, Octobe 4, 1976 at 7:00 p.m. The Honorable William H. Pussell, County Judge, presiding and Mrs. Addie Ruth Clarke, Deputy Clerk of Said Court was present; Whereupon, Chief Deputy Sheriff Luke Bright opened Court, led the Pledge of Allegiance to the Flage, and introduced the Reverend R. L. Davis, Pastor of the Corinth Baptist Church, who gave the invocation.

The minutes were approved as distributed. A motion was made by Squire Hudson and seconded by Squire Blair and was unanimous vote.

The Court recognized those people in the audience who wished to be recognized and make statements to the Court. The first person seeking recognition was Bobby Johnson of Lenoir City, who requested the Court that the auxilary police be given increased funds to purchase materials and supplies for the auxilary police divisions. He was advised to submit budget requests then to be involved in the regular budget process for the coming fiscal year.

The next person to be recoznized was Mrs. Lois Miller who represented a delegation of citizens from the Piney Community who requested that some action be taken to repair a steep road where the school bus was not coming during bad weather. The Court on motion of Squire Bledsoe and seconded by Blair and Duckworth unanimously passed a resolution calling upon the road commissioner for the 1sta and 4th districts, Erk Millsaps, to take immediate steps to put the road in such a condition that a school bus would not have difficulty in ascending the road.

SUBJECT: LOUDON COUNTY REGIONAL PLANNING COMMISSION REPORT

The Loudon County Regional Planning Commission met in regular session on September 16, 1976 and took action on the following items:

- 1. Reconsidered and recommended on a split vote the rezoning of portions of parcel 6-0 and 6-1, Tax Map 42, from A-1, Agriculture to R-1, Suburban Residential. The property is located on SR72 in the 4th Civil District and is owned by Mr. J.B. Whaley. During the discussion at the meeting Mr. Whaley assured adjacent property owner Ben Galyon that he (Whaley) would be responsible for any damages to the Galyon property and any liabilities arising from claims of the residents of the apartments with respect to possible accidents due to the farming activities on the Galyon farm. A public hearing to consider this request has been called for the November court meeting.
- Recommended on a split vote that parcel 7-0, Map 18 be rezoned from R-1, Suburban Residential to C-2, General Commercial. The property is located on Martel Road near the railroad overpass in the 2nd Civil District and is owned by George Sarten.
- Recommended that the streets in the Point Harbour Subdivision be accepted as public roads. The roads have been inspected and approved by Road Engineer Tom Davis.

In other action the planning commission agreed to delete from the agenda consideration of a proposal to realign a portion of Rest Camp Road as requested by the petitioner's attorney Mr. William Crabtree; scheduled review of a rezoning request by Mr. Tom Williams for the October meeting; and postponed consideration of a rezoning request by Margie Stooksbury due to the absence of the petitioner.


