Russell, County Judge presiding and Mrs. Addie Ruth Clarke, Deputy Clerk of said Court was present; Whereupon, Chief Deputy Sheriff Luke Bright opened Court, led the Pledge of Allegiance to the Flag, and introduced the County Chaplain, Reverend Charles Redmond, Pastor of the First Baptist Church, Lenoir City, Tennessee, who gave the invocation.

APPROVAL OF MINUTES

It was moved by Squire Williams, seconded by Squire Hudson that the minutes of the Quarterly County Court meeting of February 7, 1977 be approved and the vote was unanimous for this.

REQUEST BY MRS. WALTER BURKHART TO BE PLACED ON APRIL AGENDA

The Court recognized Mrs. Walter Burkhardt who presented the Court maps and deeds of property which she owns and explained to the Court the problems sh had encountered concerning the subdivision regulations and asked if she could be placed on the agenda for the next County Court meeting.

RESOLUTION COMMENDING STEVE CAMPBELL

The Court then recognized Squire Conner who read a resolution to the Court commending the work of State Planner Steve Campbell who has resigned to take another job in Nashville. It was moved by Squire Conner and seconded by Squire Williams that this resolution be accepted and the vote was unanimous for this. It is attached hereto as Resolution No. 2-77, Exhibit H.

REQUEST BY SQUIRE HUDSON FOR CONSIDERATION OF INSURANCE HELP FOR VOLUNTEER FIRE DEPARTMENT

The Court recognized Squire Hudson who asked that a community near Geenback had bought a fire truck and was wanting help with the insurance and asked that this matter be put on the agenda for the next County Court meeting.

REPORT ON LOUDON COUNTY INVOLVED LAWSUITS

The Court then gave an updated report upon law suits involving Loudon County. In a lawsuit involving the Election Commission's retirement program the Court ruled that they were employed by Loudon County and were entitle to retirement pay. Judge Russell reported that back retirement pay would have to be

-computed through 1972. In the lawsuit involving Loudon County and the Sheriff's Department the Court returned a verdict of \$500 damages plus \$1000 punitive damages. The Court also reported on the case of Kenneth Brown and stated that the Court of Appeals upheld the metit board.

The Court then recognized Mr. Bart Iddins, Chairman of the Committee of 100 industrial development who presented the Court with a resolution concerning the Clinch River Breeder Reactor and asked the Court to recommend its completion. Squire Conner moved and was seconded by Squire Blair to recommend the resolution favoring the Clinch River Breeder Reactor Project. The vote was unanimous for this and letters were to be sent to all concerned. It is attached hereto as Resolution No. 3-77, Exhibit 13.

The Court recognized Mr. Steve Campbell who gave the general report for the Loudon County Planning Commission and it is attached hereto as exhibit C. Mr. Campbell then read a letter from Attorney Charles Eblen who represented Mr. Robert Bivens who requested an appeal to the Court concerning the building of a body shop on Highway 72. Squire Blair moved that the appeal be granted. The motion died for lack of a second.

Building Commissioner Jack Henry was then recognized by the Court to give the building commissioner's report for the past month. Mr. Henry reported that he had taken in a total of \$822 adding a combined total to the tax rolls of \$285,000.

The Court recognized Highway Commissioners Greenway and Malone who both stated the extensive road damage caused by the severe winter. Mr. Greenway asked the Court to consider a one cent gasoline tax to improve the road situation

The Court then recognized Squire Williams who nominated Mr. John Roberts to the Loudon County School Board. Squire Blair moved and was seconded by Squire Bledsoe to cease nominations and elect Mr. Roberts by acclamation. It was done.

Squire Hamilton was recognized by the Court to give the Purchasing Committee report and it is attached hereto as Exhibit 14.

Mark Steven Campbell





WHEREAS, the American people have become increasingly aware that energy is one of our greatest needs and problems and,

WHEREAS, the magistrates of the County of Loudon in response to the will of the people of said County wish to address themselves to the solution of this vital need so that emergencies such as that just experienced by our citizens during the past winter may be averted and,

WHEREAS, the general opinion and consensus of our citizenry, East Tennessee being one of the hardest hit areas during the crisis, is that our only hope of energy sufficiency is the successful development of the liquid metal fast breeder reactor of which the Clinch River Breeder Reactor is our national pilot model, being supported by governments, private industries, and 740 electric systems across our nation and,

WHEREAS, our citizens wish to insure the benefits of this project and believe this project to be of immense importance to the welfare of both our area and our nation,

THEREFORE BE IT RESOLVED, that the Loudon County Quarterly Court strongly recommends the further development and final completion of the Clinch River Breeder Reactor.

guide in considering zoning decisions.

industrial sites for purposes of including the
sites in the Industrial Development Program
study.
3. Heard staff reports from Building Commissioner
Jack Henry.
