

SUBJECT: GENERAL REPORT OF THE LOUDON COUNTY REGIONAL PLANNING

COMMISSION

At its July 19, 1979 meeting the Loudon County Regional Planning Commission considered the following:

- 1. Heard a request by James W. Bivens to rezone Parcel 8, Map 11 from R-1, Suburban Residential to C-2, General Commercial. The property is located off Waller Ferry Road. The commission recommended that the property not be rezoned to C-2, because it would be spot zoning and because the car repair business now operating on the property without approval is adversely affecting the neighborhood property values and environment. A public hearing before the county commission has been scheduled for the September meeting.
- 2. Heard a request by Herbert Morrow to rezone Parcel 2-1, Map 11-K from R-1, Suburban Residential to C-2, General Commercial. The property is located off Highway 70. The commission recommended that the property not be rezoned since it would be spot zoning and because the proposed used car sales business would conflict with adjacent residential land uses. About eight junk cars are now located on the property. A public hearing has been scheduled for the September meeting.
- 3. Considered a rezoning request by Cecil Cook for Parcel 36, Map 29-J (across from Memorial Gardens Cemetery) from A-2, Rural Residential to R-1, Suburban Residential. The commission recommended that the lot not be rezoned because it would be spot zoning and not in conformance with the land use plan. The rezoning would be for a mobile home which was placed on the same property as an existing house without a permit. A public hearing has been scheduled for the September meeting.
- 4. Passed a resolution endorsing the TASS application to ARC for water system improvements.
- 5. Elected planning commission officers.
- 6. Adopted the program design and a "Certificate of Recording" to apply to plats which have all lots of five acres or larger.
- Heard the road engineer's report on subdivision road building activity.
- 8. Recommended to the county commission that the language of the Road Acceptance Manual on page 11 (Section III, Paragraph 9) regarding the installation of utilities for new roads be clairified so that it is understood that the extension of underground utilities be installed according to the standards of the State Health Department and that the extension of adequate public water service is one of the requirements contained in the set of standards for the acceptance of new roads which must, according to the manual, meet the same standards for subdivision roads. This matter is scheduled for consideration by the county commission at its next meeting.

PRIVATE CHAPTER NO. 172 HOUSE BILL NO. 1419

AN ACT to create a County Board of Education for Loudon County; to provide for election of members of such board; and to provide for the duties, powers, and compensation of the members of such county board of education and to repeal Chapter 74 of the Private Acts of 1979.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. The County Board of Education of Loudon County shall consist of nine (9) numbers. The school districts shall be the same as the districts from which members of the county legislative body are elected. The number of members elected from each district shall be the same as the number of members of the county legislative body elected from such district. As the term of each member of the existing board of education becomes vacant, the county legislative body shall appoint a person to fill the position until the next General Election as provided in Section 2 of this act. Each member of the county board of education shall be a resident of the district from which such member is elected.

SECTION 2. At the 1980 August General Election, four (4) members of the County Board of Education shall be elected for a term of four (4) years; one member each elected from District 2 and District 3; and two (2) members Elected from combined Districts 1 and 4. At the 1982 August General Election, two (2) members shall be elected for a term of two (2) years; one (1) member each elected from District 2 and District 3. In the 1984 August General Election, eight (8) members shall be elected for a term of four (4) years; two (2) members each elected from Districts 2, 3, 5 and combined Districts 1 and 4. In the 1986 August General Election, one (1) member shall be elected for a two (2) year term from combined Districts 1 and 4. In the 1988 August General Election and every four (4) years thereafter, nine (9) members shall be elected for a term of four (4) years.

SECTION 3. Whenever a vacancy occurs on the board of education, the county legislative body shall appoint a person to serve until the next General Election, at which time a person shall be elected to fill the unexpired term.

SECTION 4. The duties and compensation of members of the county board of education shall be as provided by law.

SECTION 5. Nothing in this Act shall be construed as having the effect of removing an incumbent from office or abridging the term of any official prior to the end of the term for which he was elected.

SECTION 6. Chapter 74 of the Private Acts of 1979 is repealed.

SECTION 7. If any provision of this Act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be give effect without the invalid provision or application, and to that end the provisions of this Act are declared to be severable.

SECTION 8. This Act shall have no effect unless it is approved by a two-thirds (2/3) vote of the county legislative body of Loudon County. Its approval or nonapproval shall be proclaimed by the presiding officer of the county legislative body and certified by him to the Secretary of State.

SECTION 9. For the purpose of approving or rejecting the provision of this Act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective upon being approved as provided in Section 8.
