RESOLUTION FIXING THE TAX LEVY IN LOUDON 89-80 COUNTY, TENNESSEE FOR THE FISCAL YEAR BEGINNING JULY 1, 1980

SECTION 1. BE IT RESOLVED, by the Loudon County
Board of Commissioners of Loudon County, Tennessee assembled
in adjourned session on the 13th day of June 1980, that the
combined property tax rate for Loudon County, Tennessee for
the fiscal year beginning July 1, 1980, shall be \$5.94 on each
\$100.00 of taxable property within the boundaries of the City
of Lenoir City and \$6.89 on each of the \$100.00 of taxable
property in Loudon City, Philadelphia, Greenback and rural
Loudon County, which levy is to provide revenue for each of
the following funds and otherwise conform to the following
levies:

SECTION 2. BE IT FURTHER RESOLVED, that this resolution take effect from the after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Loudon County Court.

## RESOLUTION FOR LEVYING AN ADDITIONAL SALES 90-80 AND USE TAX

Be it resolved by the Board of County Commissioners of Loudon County, Tennessee:

Section 1. The resolution of the Board of County
Commissioners of Loudon County, Tennessee, imposing a local sales
and use tax as authorized under the provisions of Section
67-3049--67-3056, of the Tennessee Code Annotated, adopted by
the Court at a regular meeting April Term 1976 of record in
Minute Book 17, page 350, is amended to levy a local sales and
use tax at a rate of one-half of the rates levied in the
Retailers' Sales Tax Act, Chapter 30, Title 67, TCA, as amended,
so long as the general state rate continues at 4.5 per cent, and
at three-fourth of the state rates is and when the general state
rate is reduced to 3 per cent and on farm and industrial
machinery and on water sold to or used by manufacturers at the
rate of one-half of 1%, and to increase the maximum tax on the
sale or use of any single item to \$7.50.

Section 2. If a majority of those voting in the election required by Section 67-3053, TCA, vote for the increase in the tax imposed by this resolution, collection of the increased tax levied by this resolution shall begin on the first day of the month occuring 30 or more days after the County election commission makes its official canvass of the election returns.

Section 3. The Department of Revenue of the State of Tennessee shall collect the additional tax imposed by this resolution concurrent with the collection of the state tax and the local tax now being collected for Loudon County, in accordance with rules and regulations promulgated by the said Department.

Section 4. The County Judge is hereby authorized to contract with the Department of Revenue for the collection of the additional tax imposed by this resolution, and to provide in said contract that the Department may deduct from the tax

collected a reasonable amount of percentage to cover the expense of the administration and collection of said tax.

Section 5. In the event the tax is collected by the Department of Revenue, suits for the recovery of any tax illegally assessed or collected shall be brought against the County Judge.

Section 6. A certified copy of this resolution shall be transmitted to the said Department of Revenue by the County Court Clerk forthwith and shall be published one time in a newspaper of general circulation in Loudon County prior to the election called for in Section 2 hereof.
