# RESOLUTION 8-83

WHEREAS, Loudon County is engaged in a joint endeavor with the City of Loudon and the City of Lenoir City to obtain a suitable and adequate site for the establishment of a sanitary land fill; and

WHEREAS, application for special grants is a part of the project, and certain deadlines are involved in the application for grants and in proceeding with the general problem of locating a suitable site, which involves the examination of the soil of the particular site, as well as other examinations, core drillings, etc. that can only be done by a physical entrance onto the property; and

WHEREAS, the joint committee, working with other governmental authorities and agencies have established certain parcels of land as being the most suitable from a standpoint of soils, rock formations, lay of the land, location of the site for economical reasons, etc.; and

WHEREAS, one such site namely, property owned by Arthur Simmons and wife Karen Simmons, in the Fourth Civil District of Loudon County, Tennessee, being a farm of something less than 400 acres, of which approximately 100-125 acres appears to be very adequate; and

WHEREAS, the committee has been unable to make arrangements to enter upon the land for the purpose of taking the necessary core drillings, etc. by agreement with the owner; and

WHEREAS, it now appears that it will be necessary to file a petition with the Circuit Court of Loudon County for the purpose of obtaining the necessary Court Order to allow for the investigation and examination of a portion of the Simmons farm for the purpose of deciding whether or not a portion of the farm might be suitable for the location of a sanitary land fill;

NOW, THEREFORE, be it resolved by the Loudon County Commission that the Arthur Simmons farm located in the Fourth Civil District of Loudon County, Tennessee (the said farm being designated on the tax maps of Loudon County as map 60, parcels 7.0, 7.1, 7.2, 6.0, and 36; map 52, parcel 25.1; map 61, parcel 1.1; and map 51, parcel 5.1) be hereby declared to be a primary site for consideration for the location of the sanitary land fill for Loudon County and it's municipalities, and that suit be authorized for the purpose of gaining authority for Loudon County, the City of Lenoir City, the City of Loudon, and the Tennessee Department of Public Health, and their agents and representatives

to enter upon the land of Arthur Simmons and wife Karen B. Simmons for the purpose of investigating the suitability of a portion of the land for the purpose of a sanitary land fill, with the county to be responsible for any damages or expenses that might arise out of the investigation, this authority to include any additional examination of the land for the purpose of appraisal in the event the land subsequently should be chosen for the location of a sanitary land fill site, and condemnation is necessary, it being the desire of the County Commission that the matter be worked out by agreement if possible, even to the point of obtaining the use of the land under a lease agreement rather than outright acquisition.

HOUSE BILL NO. 48 by Davidson

10-83

AN ACT relative to eracting certain signs within highway rights-of-way which provide direction information for business establishments offering certain goods and services to the traveling public, and to amend Tennessee Code Annotated, Title 54, Chapter 21.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 54-21-103, is amended by inserting the following language in item (1) between the words "pertaining to" and "natural wonders": the availability of food, lodging, vehicle service and tourist information,

SECTION 2. Tennessee Code Annotated, Title 54, Chapter 21, is amended by adding Section 3 through 6 of this act as new sections to be appropriately numbered.

SECTION 3. Specific information signs identifying businesses providing "GAS", "FOOD", "LODGING", or "CAMPING", which signs shall conform to the provisions of the National Standards for Specific Information Signs directive (FHPM 6-8-3-8), dated February 9, 1979, shall be made available for installation along the interstate highways of this state.

SECTION 4. As used in this act unless the contex otherwise requires:

- (1) "Sepcific information sign" means a rectangular sign panel with:
  - (a) The words "GAS", "FOOD", "LODGING", or "CAMPING";
  - (b) Directional information; and
  - (c) One or more business signs.
- (2) "Business sign" means a separately attached sign mounted on the rectangular sign panel to show the brand, symbol, trademark, logo, name, or combination of these, for a motorist service available on a crossroad at or near an interchange or intersection.

SECTION 5. Each business identified on a specific information sign shall have given written assurance to the director of highways of its conformity with all applicable laws concerning the provision of public accommodations without regard to race, religion, color, sex, or national origin, and shall not be in breach of that assurance.

SECTION 6. The director of highways shall establish minimum criteria by which gas, food and lodging establishments may qualify for participation in specific information signing for travel services within interstate rights-of-way which shall include but not be limited to the following criteria:

- Distances to eligible services;
- (2) Selection of eligible businesses;
- (3) Use of business signs and legends at intersections on interstates conforming to the size and legend provisions of paragraph 8c(1) and 8c(2), respectfully, of the National Standards for Specific Inforation Signs directive (FHPM 6-8-3-8) dated February 9, 1979;
- (4) Removing or covering business signs during off seasons for businesses operated on a seasonal basis;
- (5) Prescribing the circumstances, if any, in which specific information signs may be used outside rural areas; and
- (6) Determining the costs to businesses for initial permits, installation, annual maintenance, removal, and other costs which may arise in connection with such business signs.

SECTION 7. This act shall take effect July 1, 1983, the public welfare requiring it.
