RESOLUTION NO. 55-86

RESOLUTION APPROVING TELLICO AREA SERVICES SYSTEM CONTRACT WITH TELLICO RESERVOIR DEVELOPMENT AGENCY AND MONROE COUNTY

WHEREAS, Tellico Area Services System (TASS) is a utility agency jointly owned by Loudon County and Monroe County, its Board membership being composed of the members of the Loudon County Board of Public Utilities and the Monroe County Board of Public Utilities; and

WHEREAS, the main water line between the TASS water plant across (under) Tellico Lake to the Monroe County side of the lake has had a major break on three different occasions, costing more than \$100,000 in repairs in the last few years, and jeopardizing the public health and safety of many citizens; and

WHEREAS, TASS, Monroe County, and the Tellico Reservoir Development Agency (TRDA) have been working on plans for an alternate main water line to be attached to the U.S. 411 bridge across Tellico Lake so that the water supply to all areas west of Tellico Lake, including the Town of Vonore, City of Madisonville, Monroe County Industrial Park, TRDA Industrial Park, and the Cooper Communities development will not be endangered, and Monroe County has applied for and received confirmation of grants in the amount of \$325,000 toward the completion of this project, and TASS has agreed to supply \$25,000, and TRDA has agreed to loan TASS up to \$100,000 to complete the alternate main line project across the U.S. 411 bridge, provided that TASS repay the loan (interest-free) in 18 years, in graduated payments; and

WHEREAS, in addition TRDA has authorized a new marina/resort project for the Seven C's/Tellico Harbor development in the Nine Mile Creek area, and has agreed to loan to TASS interest-free, the amount of approximately \$255,000 to construct a sewer line from the Monroe County (Niles Ferry) Wastewater Treatment Plant to the new Seven C's development just south of U.S. Highway 72, and further has agreed to loan TASS

approximately \$65,000 to construct a new water line to the new Seven C's/Tellico Harbor development, the said sewer and water lines to be available to other residents and developments on the east side of the lake, with TASS to pay back the said loans with 1/2 of the gross revenues coming from those lines, and 1/4 of the gross revenues coming from extensions from said lines, with the balance to be used by TASS for its operations, expense and indebtedness; and

WHEREAS, TRDA as a prerequisite to making the has requested the endorsement and approval of Loudon County and Monroe County, and further specifically requests the acknowledgment and approval of the payback schedule for the new main line across the bridge, and an approval that the commitment of TASS revenues in accordance with the schedule as approved by the TRDA Board on September 17, 1986, has precedence and priority over other indebtedness owed by TASS to Loudon County and Monroe such prior indebtedness owed by TASS to the Counties being subordinated to revenue from the new water line and sewer line constructed with TRDA loan funds, in the amount of 50%, which will go to repay the TRDA loan as outlined above; and that one-fourth of any revenue received by TASS from any future extensions to the new water and sewer lines outlined herein will be paid to TRDA, and that Loudon and Monroe Counties subordinate their rights in and to said revenues to TRDA as to one-half (1/2) and one-fourth (1/4) of said revenues, respectively, as described hereinabove; and

water and other utility services to industry and residences in the southern portion of Loudon County and the south and eastern portions of Monroe County, and the extension of the lines is needed to promote and assist the new development which ultimately will be of great benefit economically to the area, and will enable TASS to increase its revenues and more readily assume its indebtedness.

NOW, THEREFORE, BE IT RESOLVED by the Loudon County

Board of Commissioners, in regular session assembled, on this the 3rd day of November, 1986, that Loudon and Monroe Counties, by passage of this resolution, do hereby agree that TASS may pay one-half (1/2) of their water and sewer revenues received from the water and sewer line extensions outlined herein, and further agree that TASS may pay one-fourth (1/4) of their revenue received from any extensions to the water and sewer line extensions outlined above, to TRDA, and to that extent Loudon and Monroe Counties subordinate their rights to have said revenues paid toward the present bonded indebtedness of TASS.
