It was moved by Commissioner Twiggs and seconded by Commissioner Price to postpone adopting the budget for the 1992-1993 fiscal year until the next meeting. On Roll Call the vote was 6 to 3 against the motion with Twiggs, Price and Blair voting for it.

Concerning pay raises for county employees, it was moved by Commissioner Maples and seconded by Commissioner Williams that by trimming three budget items:  
(1) \$20,000 from the Tourism Budget  
(2) \$15,000 from the Industrial Budget  
(3) \$10,000 from the East Tennessee Resource Valley  
making \$45,000 for the 3% raise for the employees. On Roll Call the vote was 6 to 3 against it with Blair, Maples and Williams voting for the 3% raise for the County Employees.

It was moved by Commissioner Millsaps and seconded by Commissioner Park that the Budget recommendations with a 4% reduction in all departments presented by the Budget Committee be approved. On Roll Call, the vote was 5 to 4 in favor with Commissioner Millsaps, Park, Blair, Bledsoe and Masingo voting for the recommendation.

Concerning the Budget Recommendations, it was moved by Commissioner Williams and seconded by Commissioner Twiggs to clarify the recommendations and take another vote. On Roll Call, the vote failed with Commissioner Bledsoe, Millsaps, Price, Masingo and Park voting Nay.

It was then moved by Commissioner Millsaps and seconded by Commissioner Twiggs to cut \$45,000 from the Commissioners pay themselves to fund the 3% raise for County Employees. On Roll Call, the vote was five against it and four for it. Those against it were: Blair, Maples, Price, Masingo, and Williams.

Attorney David Black (Board Member) spoke concerning TRDA Parkway. After voting to take over the (TRDA) parkway on June 1st, it was moved by Commissioner Williams and seconded by Commissioner Maples to resend that Resolution and give it back to TRDA. On Roll Call, the vote was 5 to 4 to give the parkway back to TRDA with Commissioner Williams, Maples, Blair, Price and Park voting to give the parkway back to TRDA.
