Suit has been threatned, but because of a recent revision to the County Zoning Regulations, wherein all building permits for commercial enterprises are to be referred to the Director of Planning before the issuance of the permit, the firecracker vendors have been advised that even though the Building Commissioner has denied the issuance of permits, that first an appeal should be made to the Director of Planning, as well as to the Board of Zoning Appeals, before suit is filed. However, most of the vendors apparently have overlooked all of this and have gone ahead and are operating. In answer to a question, County Attorney Sproul stated that by following the procedures set forth in the Tennessee Code and in the County regulations, the County Commission could make amendments to the County Zoning Regulations that probaly would eliminate most of the questions of alleged illegality in the future.
