A RESOLUTION AMENDING THE ZONING MAP OF LOUDON COUNTY, TENNESSEE. PURSUANT TO CHAPTER FOUR, SECTION 13-7-105 OF THE TENNESSEE\_CODE ANNOTATED, TO REZONE PROPERTY BOUNDED BY RAILROAD TRACKS, MARTEL ROAD, SHAW FERRY ROAD, OLD MIDWAY ROAD, AND WILSON ROAD TO INCLUDE R-E. SINGLE FAMILY EXCLUSIVE OVERLAY DISTRICT, EXCLUDING ALL COMMERCIAL PROPERTY IN THE BOUNDED AREA

WHEREAS, the Loudon County Commission in accordance with Chapter Four, Section 13-7-105 of the Tennessee Code Annotated, may from time to time, amend the number, shape, boundary, area or any regulation of or within any district or districts, or any other provision of any zoning resolution, and

WHEREAS, the Regional Planning Commission has forwarded its recommendations regarding the amendment to the Zoning Map of Loudon County, Tennessee, and the necessary public hearing called for and held,

NOW, THEREFORE, BE IT RESOLVED by the Loudon County Commission that the Zoning Map of Loudon County, Tennessee be amended as follows:

1. That property bounded by Railroad Tracks, Martel Road, Shaw Ferry Road, Old Midway Road, and Wilson Road include R-E, Single Family Exclusive Overlay District, excluding all commercial property in the bounded area, as represented on the attached map; said map being part of this resolution.

BE IT FINALLY RESOLVED, that this resolution shall take effect immediately, the public welfare requiring it.
