## **COUNTY COMMISSION MEETING** MAY 6, 1996

(1) Call to order. roll Call

> Be it remembered that the Loudon County Legislative Body met in regular session on May 6, 1996 at the Loudon County Courthouse Annex, with the Chairman Roy Bledsoe presiding, County Court Clerk, Riley D. Wampler, and County Executive George Miller were present, whereupon Sheriff Tim Guider opened Court, led the Pledge of Allegiance, and Mr. Howard Luttrell gave the Invocation. Chairman Bledsoe asked if the County Executive had any corrections to the proposed agenda: Mr. Miller noted these changes:

- Addendum: Possible adoption of Special Called Meeting of April 1. 22, 1996. The minutes sent out earlier have had some corrections, if it is the wish of the Commission, they could be adopted later in the meeting.
- 2. These two deletions: (1) Item (4-B-b)concerning .25 per sheet charge for County records

(2) Mr. Russ Lewis (4-C-c), who wished to address Commission.

Commissioner Park made motion that the minutes of April 1, 1996 be approved, and Commissioner Masingo seconded the motion. County Attorney, Harvey Sproul asked the following correction be considered: Mr. Sproul stated that he did not say that the County Commission didn't have the authority to approve zoning requests." The County Commission approves all zoning matters, concerning changes to the zoning map or changes to the regulation, the things that County Commission do not have the authority to do are variances, special exceptions, and interpretation of the Zoning regulations. He is asking that the minutes be revised to reflect this, rather than his previous statement saying County Commission does not have the authority to do zoning requests." Commissioner Park agreed toapprove this correction, with Commissioner Masingo also agreeing to the request. Voice vote of the Commission indicated motion carried.

Contract Approval	Clarification of Beals Chapel Road Resolution and Contract with DOT: The contract was examined by the County Attorney, and he felt this should be brought back to the Commission. According to the Contract the County could incur some liability should the completed highway construction not meet specifications(according to the grant). Road Commissioner, Don Palmer assured the Commissioners that he had always worked closely with the State, and it was unlikely to occur. Mr. Miller asked the Commission to take another vote and authorize the adoption of the contract as per the wording. #### RESOLUTION APPROVING CONTRACT WITH STATE DEPARTMENT OF TRANSPORTATION -U.S. 411 HIGHWAY FROM EXISTING 4-LANE SECTION NORTH OF LITTLE TENNESSEE RIVER TO STATE ROUTE 95 NEAR GREENBACK

WHEREAS, the State of Tennessee Department of Transportation has proposed Federal Project No: STP-NH-33(19), State Project No: 53005-2211-14-Loudon County: U.S Highway 411 SR-33) from existing 4-lane section north of Little Tennessee River to State Route 95 near Greenback.

WHEREAS, prior to the beginning of construction work a written contract between the department and the County is required; and

WHEREAS, the responsibility of the County under this contract basically is to notify the State of any suits that may be filed, to donate any real property owned by the County, if it is required in the project, to move any utilities owned by the County, that may be involved in the project, to move any utilities owned by the County that may be involved in the project, to furnish any traffic control devices required, and to waive enforcement of County setbacks/building lines and ordinances which may be violated as a result of the project; and

NOW, THEREFORE, BE IT RESOLVED that the Loudon County Commission, in regular session, assembled on the 6th day of May 1996, does hereby approve this project, and incorporated the proposal into this Resolution, a copy of which is attached as an Exhibit hereto, the County Executive being authorized to execute the contract on behalf of the County.
