WHEREAS, the statute authorizing the creation of a Wastewater Treatment Authority provides that a public hearing must first be held to give the citizens and the public a chance to comment and discuss this option before a decision is made by the county legislative body.





Whereas, applicant desires to remove any encumbrance caused by the presence of the road bed which may lessen property values; and

Whereas, the vacating of this portion of road will only affect the property owner and not adjoining property owners; and

Whereas, the Loudon County Regional Planning Commission has reviewed this matter and recommends that the vacating of said road and corresponding right of way will not adversely affect property or function of the County's roadway system and recommends that said right of way be vacated as follows:

**Section 1**. Beginning at a point on McKelvey Road, being a common point with Parcel 29.00 and 28.00, Tax Map 55, and continuing in a southeasterly direction for a distance of 500' + /-; thence in a northeasterly direction for a distance of 800' + /- to a point of intersection of the abandoned road bed with McKelvey Road.

**Now, Therefore, Be It Resolved**, that the Loudon County Commission considers the vacating of the preceding right of way not to be detrimental to the community or function of the existing roadway system and that the aforementioned section of right of way for this unnamed abandoned road bed be vacated and interest in the right of way relinquished.

**Be It Further Resolved**, that the Loudon County Commission hereby authorizes the execution, by the County Attorney and County Executive, of a quitclaim deed for that portion of right of way dividing Parcel 29.00, Tax Map 55 and more specifically shown on the attached map, said map being a part of this Resolution

**Now, Therefore, Be It Finally Resolved,** that this Resolution shall take effect immediately the public welfare requiring it.



### RESOLUTION ADOPTING TENNESSEE CODE ANNOTATED 54-10-216 AS THE PROCEDURE FOR CLOSING PUBLIC ROADS IN LOUDON COUNTY

WHEREAS, over many years, the statutory method of closing public roads by the county legislative bodies in Tennessee has been confusing and vague as to the procedures to be followed; and

WHEREAS, in Loudon County, likewise, the procedures followed by the Highway Superintendent and the County Commissions have been inconsistent, and on at least one occasion, has resulted in a lawsuit contesting the validity of the closing of a road; and

WHEREAS, the Tennessee General Assembly in recent years has enacted a new statute which, if approved and ratified by a two-thirds (2/3) majority of the county legislative body, establishes precise and definite procedures in closing roads, which includes an investigation, and notification of all parties who might have an interest in particular roads that are being considered for closing; and

WHEREAS, it is the desire of the Loudon County Commission to establish a specific uniform procedure for the closing of public roads in Loudon County.

NOW, THEREFORE, BE IT RESOLVED by the Loudon County Commission, in regular session assembled this <u>5th</u> day of <u>October</u>, 1998, as follows:

- The provisions of Tennessee Code Annotated 54-10-216 are hereby adopted for the closing of public roads which are not maintained by any other governmental entity.
- 2. Upon adoption, the provisions as set forth in T.C.A. 54-10-216, and any future amendments of that statute adopted by the Tennessee General Assembly, shall govern all future applications for the closing of public roads in Loudon County.
- 3. This resolution shall be effective upon passage by a twothirds (2/3) majority vote of the county legislative body of Loudon County, the public welfare requiring it.
