Report on flood study

Executive Miller reported that the Army Corps of Engineers will be funding a preliminary study on the flood problem areas in the county. The areas that they will be studying are Bat Hollow watershed, Town Creek watershed and Browder/Huntsville Hollow watershed. The study will begin early to mid January.

Report from jail committee

Commissioner Park reported that minutes from the December meetings of the Jail/Judicial System Facilities Needs Study Committee were forwarded to the Commissioner Park answered questions from the Commissioners in their packets. commission regarding the progress of the Committee and reported that Mr. Jennings from CTAS will have a report and recommendations for the committee in February

(15) Request for report from John Deere

Commissioner Park requested a report from the John Deere facility in Loudon County and requested that Executive Miller and Mr. Pat Phillips report to commission in February on the number of employees and the productivity of this plant. Commissioner Randolph reported that the Loudon facility has 243 employees and they are looking at a possible expansion.

Commission Park commented on the newspaper article in the November 16, 1998 issue of the News-Herald regarding Yale Security in Lenoir City. This article by the Environmental Defense Fund was a news release that reported Yale was named the top area polluter. Commissioner Park reported that this group released information that was incorrect and that Yale was never out of compliance with the EPA.

(16)Discussion of hiring planner

Commissioner Park questioned the hiring of the new Planner and who has the authority to hire a planner. Executive Miller reported the authority was delegated by a preceding county commission along with the two city councils to the Executive Planning Council on a five-year term agreement. Commissioner Park requested this issue be placed on the January workshop agenda and the Intergovernmental Affairs Committee agenda. Commissioner Jenkins reported that he is the County Commission representative to the Executive Planning Council. Commissioner Jenkins explained the process of hiring the new planner.
