

This letter defines three (3) options of how to proceed into construction on the Justice Center additions.

OPTION ONE: TRADITIONAL

Under this option we proceed under the traditional method of finishing the bidding documents (drawings and specifications), advertise in newspapers for any and all contractors interested to pick up bid documents and prepare bids, award to the lowest qualified bidder, and proceed into construction accordingly. BWSC will continue our services into construction as is normal and customary, i.e. we will visit the job site periodically to observe the progress of construction, work through issues and problems with the contractor, prepare change orders as necessary, review shop drawings and submittals, and other tasks as are defined in our contract.

OPTION TWO: PRE-QUALIFYING

The only difference in this option versus Option One is that the bidding documents would contain provisions for the contractor to be pre-qualified, i.e. we would set a minimum standard of past jail construction experience for them to meet before they can bid the project. The advertisement in the newspaper for bidders would read something like as follows:

Loudon County will be accepting bids on December 25, 2000 for the construction of additions and renovations to the justice center. Interested contractors must meet the minimum pre-qualifications of having successfully completed one (1) jail project of \$1,000,000 or more, and a jail project including renovation. Interested bidders may review the documents at the county purchasing office, the bidder rooms, or Barge, Waggoner, Sumner and Cannon, Inc. Bidding documents may be obtained for a deposit of \$200 at the offices of BWSC.

BWSC will continue our services into construction as is normal and customary, i.e. we will visit the job site periodically to observe the progress of construction, work through issues and problems with the contractor, prepare change orders as necessary, review shop drawings and submittals, and other tasks as are defined in our contract.

OPTION THREE: CONSTRUCTION MANAGER

Under this option BWSC will provide some additional drawings and information (to our current schematic design package), for interested construction managers to bid from. The construction manager will act in the same basic capacity as a general contractor, i.e. they will obtain bids from three (3) or more suppliers or subcontractors for each of the major phases of work (i.e. such as major equipment and material supplies, HVAC systems, doors, windows, electrical systems, etc, etc.). The contractor may also perform a portion of the services themselves, such as:

general clean up and labor, they may do masonry if they have this in house and can be more competitive, etc. The advertisement in the newspaper for this would read such as follows:

Loudon County is seeking proposals from construction firms to provide construction management services for additions and renovations to the Loudon County Justice Center. Qualification packets can be obtained from the purchasing agent, Howard Luttrell. The minimum qualifications and ranking criteria is as follows:

Successful completion of at least one (1) jail project over \$1,000,000.	25 points
Successful completion of at least one (1) jail renovation project.	10 points
A bid price in the form of a guaranteed maximum price, based on design development documents prepared by BWSC.	35 points
Contractors method, or sequencing of how to accomplish the project.	15 points
The designated superintendent for the project, and their experience with related facilities.	15 points

The construction manager attends our meetings, and provides input on constructability, detailing and the variety of issues we are discussing at the time. Periodically the construction manager may make a suggestion or a change request after we have made decisions and proceeded accordingly. If this happens, the following scenario occurs: the construction manager could request that we change various wall bearing systems from concrete block to steel frame, in order to save time and dollars. The block wall systems would have been agreed upon by all parties previously, however, the contractor might want to change for a variety of reasons. construction manager may say this will save \$8,000 off of the guaranteed maximum price they have given. However, the architect will be required to make modifications to the documents to accommodate this, therefore the savings to the county would be \$8,000 minus the cost for the engineers and architects to modify the documents. This is a common methodology, and one that we used at Blount County Justice Center. The bottom line is still a net savings to the county.

We have successfully completed projects using each one of the three options listed above. No one of the options is perfect, if it were it would be the only one used. However, based on our experience we would recommend the Construction Manager first, the Pre-Qualified bidder second, and the Traditional bid third for your complex project.


